#### **Howdy Days**

CW & SSB: 1400 UTC September 12, 2006 to 0200 September 14, 2006

ELIGIBILITY: All licensed women operators throughout the world are invited to participate. <u>PROCEDURE:</u> Call "CQ YL."

<u>OPERATION:</u> All bands and modes of emission may be used. A station may be worked and counted once on each band and mode for QSO points. The maximum power output that may be used at any time during the contest is 750 watt's on CW and 1500 watts PEP on SSB. Participants may work only 24 hours of the 36 hours in each contest. Operating breaks must be indicated in the log. RTTY will count as CW.

EXCHANGE: YLRL member or non-YLRL member? Entries in log must also show date, time, band, call or station worked. SCORING: Score two points for each YLRL member worked and one point for each non-YLRL member worked. There are no multipliers.

SUGGESTED FREQUENCIES: Try listening around 7.233, 14.288,14.298, 21.388, 28.433 on voice, basically frequencies ending in 33 or 88. Similarly for CW.

<u>LOGS</u>: All logs must show if operator is a YLRL member or non-member to be eligible for awards. <u>AWARDS</u>: Top scoring YLRL member will receive her choice of a YLRL pin, charm, or stationery. Top scoring non-YLRL member will receive a one-year YLRL membership.

#### YL Anniversary Party (YL-AP)

## CW:1400 UTC October 3, 2006 to 0200 UTC October 5, 2006-SSB: 1400 UTC October 10, 2006 to 0200 UTC October 12, 2006

<u>ELIGIBILITY</u>: All licensed women operators throughout the world are invited to participate. Only YLRL members are eligible for the cup awards. Non-members will receive certificates. Only YLRL members are eligible for the Corcoran and Hager awards.

#### PROCEDURE: Call "CQ-YL".

<u>OPERATION:</u> All bands may be used. No cross band operation. Net contacts and repeater contacts do not count. A station may be worked and counted once on each band. Participants may work only 24 hours of the 36 hours in each contest. Operating breaks must be indicated in the log.

EXCHANGE: Station worked, QSO number, RS(T), and ARRL section/VE province/country.

<u>SCORING:</u> (1) CW and SSB are scored as separate contests. Submit separate logs for each contest. (2) All YLs within one of the U.S. ARRL sections or within a Canadian province shall score one point for each QSO with another station located within a section or province. Score two points for each contact with a station not located within an ARRL section or province, i.e., DX. (DX stations are defined as those not located within an ARRL section or province.) (3) DX YLs shall score two points for each contact with a station on another continent and one point for each contact with a station on their own continent. (4) Multiply the number of contact points by the total number of different sections, provinces and countries worked.

LOGS: All logs must show the operator's ARRL section/VE province/or country to qualify for awards. Logs must also state whether or not the operator is a member of YLRL. For each QSO, logs must show the station worked, time, band, and date. Logs must also state the power output used. If you have 200 or more QSOs, submit a separate log for each band and submit a "dupe" sheet. Remember to file separate logs for each contest. Logs must show claimed score.

<u>AWARDS</u>: For the YLAP, cups will be awarded for both the NA-YL and the DX-YL with the highest CW scores and for the highest SSB scores. Only YLRL members are eligible to receive cups. If the winner of either contest is a non-YLRL member a first place certificate will be awarded. If a YL does not wish to receive a cup a first place certificate may be awarded. Second and third certificates will be awarded for each contest. The highest CW and the highest SSB score in each district, province and countiy will receive a certificates will be awarded only if there are at least 10 valid contacts on the log.

CORCORAN AWARD: a plaque given for the highest combined CW and SSB score for YLRL members within a state or province

HAGER AWARD: A plaque given for the highest combined CW and SSB score from North and Central America, including the Greater and Lesser Antilles, for YLRL DX members only. A duplicate plaque given for the highest

combined CW and SSB score from any other part of the world, for YLRL DX members only.

#### General Rules for YLRL Contests

1. Check to make certain you are sending logs to the CURRENT Vice-President.

2. Logs must be postmarked no later than 30 days after each contest ends.

3. Scoring:

Phone and CW contests will be scored separately. Separate logs must be submitted for each contest.One point is earned for each different station worked on each band. The same station may be

worked on different bands. In the YL-OM contest only YLs count OMs and OMs count YLs. •Multiplier will be the ARRL sections and/or DX countries, whichever is appropriate. Canadian provinces are counted individually. Multipliers are used only once on all bands when figuring the

score.Contestants running a power output of 100 watts or less on CW and 200 watts PEP or less on SSB,

at all times during the contest, earn a power factor of 1.5Computation is done by multiplying the points times the multiplier times the power factor.

•For each duplicate contact that is removed from the log by the Vice-President, a penalty of three additional and equal contacts will be exacted.

4. Logs:

• All logs must show the operator's ARRL section, VE province, or country to qualify for awards. Where applicable, logs must state whether or not the operator is a member of YLRL. For each QSO, logs must also state the power output. If you have 200 or more QSOs, submit a separate log for each band and submit a "dupe" sheet.

•Please type or print. Do not send carbon copies of logs. Photocopies are OK.

•Logs must be signed and show claimed score. No logs will be returned.

•Entries in log must also show time, band, date and transmitter power.

5. Exchange: Station worked, QSO number given and received, RS(T) given and received, and section/ province/ country.

Hollingsworth said postal records indicate that Kuth received the FCC inquiry on May 5 but did not respond. The letter to Kuth noted that the address on his renewal application differed from is actual mailing address. Kuth's Technician license expired in November 2004.

The FCC dismissed the upgrade application of Andrew O. Ojwang, KI4LTH, of Roswell, Georgia, based on the licensee's response to "numerous complaints about the operation of your station since the grant of your General class license," Hollingsworth wrote.

Following the complaints, the FCC last October set aside Ojwang's General license and his renewal application, which reverted to pending status.

"Pursuant to your response dated May 31, 2006, your General class application is being forwarded to the Wireless Telecommunications Bureau for dismissal," Hollingsworth informed Ojwang on June 28. Complaints regarding Ojwang's on-air operation would have to be resolved before the Commission would consider an upgrade application, Hollingsworth advised. The FCC appears to have renewed Ojwang's Technician ticket for a full 10-year term, however.

Meanwhile, a Texas man, Billy J. Benefiel, W5BJB, turned in his amateur license rather than respond to complaints alleging that he was operating on frequencies not authorized to him as a Technician, and for causing interference.

#### WHY YOU SHOULD ALWAYS UPDATE YOUR RECORDS!

As this is the last issue before the Directory issue, the YLRL wants to remind you to have all updates and changes in to the Database Manager by September 25<sup>th</sup>, 2006. Below is a reprint that reminds us all to keep our records updated.

Nancy Rabel Hall, KC4IYD sent this on mentioning, "I know a few people who have moved and never contacted the FCC about their change in address. We a few hams lost their license when the FCC could not contact them. I doubt the FCC will do this for people they are not explicitly looking for, but this might be a good wakeup call to everyone to make sure that their license info is up-to-date. If you are an ARRL member you can do it for free by filling out a NXCVEC form at an ARRL exam session. If you are not an ARRL member, you can up date your address at <u>www.qrz.com</u> for a fee or you can up-date it free online at <u>www.wireless.fcc.gov/service/index.htm</u> and click on Amateur Radio Services.

This is also a reminder to all YLRL members. If you do not update your records with us, you may not receive your YL-Harmonics or other important announcements and notices. -The Editor

## FCC SUSPENDS HAM LICENSES FOR FAILURE TO MAINTAIN MAILING ADDRESS

#### From the ARRL Letter

The FCC has suspended two Amateur Radio licenses because the holders had failed to maintain correct mailing addresses in the Commission's licensee database. Special Counsel in the FCC Spectrum Enforcement Division Riley Hollingsworth wrote Larry L. Smith, KC7LJR, of Middleton, Idaho, and Larry J. Maniag, KD7JTG, of Payson, Arizona, on June 28 to inform them the FCC was suspending their Technician tickets for the remainder of their license terms or until each licensee provides a valid mailing address.

In his letter to Smith, Hollingsworth noted that on three occasions in late 2005, the FCC had been unable to deliver warning notices alleging deliberate interference to a 2-meter repeater system.

He told Maniag that the US Postal Service earlier this year returned as undeliverable two warning notices alleging deliberate interference with several repeaters.

Hollingsworth cited 97.23 of the Commission's Amateur Radio Service rules that requires each license grant to show the licensee's correct name and mailing address. The rule provides that "revocation of the station license or suspension of the operator license may result when correspondence from the FCC is returned as undeliverable because the grantee failed to provide the correct mailing address."

Hollingsworth cited the same rule to an Ohio licensee apparently tempting a similar fate. On June 26 Hollingsworth afforded Robert D. Reckner, W8IQJ, more time to respond to complaints involving his service as MIDCARS net control. The complaint alleges deliberate interference as a result of his starting the net on top of existing communications on 7.258 MHz in April. A June 1 letter enclosing the complaint came back to the FCC as undeliverable, he said.

In another failure-to-reply case, Hollingsworth notified William E. Kuth, KB2SGQ, of Utica, New York, on June 27 that his license renewal application has been designated for dismissal. That action effectively eliminates Kuth's Amateur Radio privileges, and Hollingsworth reminded him of that fact.

In May, the FCC notified Kuth that his renewal application "could not be routinely granted" and had been referred to the Enforcement Bureau for review. That came in the wake of a Warning Notice for allegedly operating on 26.815 MHz without a license and causing interference on 10 meters. Additional complaints alleged that Kuth operated on 26.945 MHz.
