Happy New Year to everyone! Here's to a healthier and safer 2021 than last year.

For YLRL, 2020 was a landmark year. The organization turned 81; the May-June issue of <u>YL Harmonics</u> was the first sent via email to most of the members; the Board approved 1-year and 3-year dues payments with no prorating of dues; the Board approved the Membership Privacy Policy. That was a great deal of activity for one year. Because the dues payments are part of the By-Laws the membership will have an opportunity to vote on that before we implement it; see the information regarding that vote elsewhere in this issue.

For YLRL, 2020, that landmark year, was a busy year. 2021 is the follow-up year that will likewise be busy as we implement what we did in 2020. Here is what we have left to do.

- Continue the implementation of the Membership Privacy Policy. With the publication of the privacy policy in the 2020 November/December <u>YL Harmonics</u> the privacy policy implementation began.
  - The privacy policy is the YLRL effort to inform you as to what personal information we collect from members, and to obtain your consent before we publish your personal information. In the current environment, publication of personal information can take on a life of its own in a negative way. YLRL wants you to know that we are doing what we can to prevent that.
  - The updated membership form was published for members to copy and fill out to accompany membership payments. Right in the middle of that form is the member's consent to the privacy policy. When you renew your membership remember to read the consent statement and check the first box, which indicates your consent to the privacy policy. Without your consent to the policy, you are not a member of YLRL. I'm happy to answer any questions you have about this. Contact your Receiving Treasurer to give consent to the privacy policy; it's never too late.
  - The Photo/Video Model Release form was also published for anyone to use who submits photos of non-members for publication in <u>YLH</u>. The form when filled in and signed constitutes permission from the non-member to publish her picture in <u>YLH</u>. There are reasons in addition to being in a witness protection program that one might not want a picture published. We need to be aware of this. The form helps with that.
- Send the updated By-Laws to the membership for approval.
  - Provided the new By-Laws are approved, we will begin implementation of the 1- and 3-year membership renewals.
    - We will take a look at our membership and financial records so we can adequately account for the money received for 3-year memberships.



- 1. Talk to YL's and exchange favorite NATIONAL PARK. If you don't have a favorite NATIONAL PARK just choose a NATIONAL PARK to give out.
- 2. You will need to collect 15 different National Parks.
- 3. You will need one YL for each NATIONAL PARK. You can only use a NATIONAL PARK once. You can only use a YL once.
- 4. All contacts must be made during the 2021 year (January 1 December 31, 2021).
- 5. Contacts may be made on any band the YL is licensed to be on, and any mode including SSB, all digital modes, Echo-link, and repeaters.
- 6. Favorite NATIONAL PARK must be exchanged over the air. You cannot e-mail someone after the contact and ask them for their favorite NATIONAL PARK.
- 7. Contacts may be made during nets only if the net control allows it.
- 8. Report the following for each contact:
  - Date, time, band, first name, QTH, FAVORITE NATIONAL PARK.
- 9. Send your list, in NATIONAL PARK alphabetical order, to the Certificates Manager at any time during the year, but no later than the end of January 2022 to receive your certificate.
- 10. This certificate is available ONLY to YL's.

A few hints on the NATIONAL PARKs ...

- 1. Be specific in your choice of your favorite NATIONAL PARK. For example, please don't say, "Any NATIONAL PARK" Make sure you give the name of the NATIONAL PARK i.e. Yellowstone.
- 2. If you don't have a favorite NATIONAL PARK, go to a website and look at all the different national parks, then choose one that is unusual.

# Greetings YLs

My favorite build during the year of Covid-19 was my Morserino-32 kit which I ordered from Austria. I became familiar with the Morserino when it became quite popular with the members of the Long Island CW Club. The Morserino-32 was developed and is sold by Willi Krami, OE1WKL. <a href="http://www.morserino.info/">http://www.morserino.info/</a>.

The Morserino is a multifunction device that can be used as an external keyer, CW training generator with several modes including Koch training, training via random word/abbreviations/call signs/, CW decoder via audio input, and my favorite the echo trainer in which a word/phrase/sentence etc. It is an interactive training device to learn and send CW correctly with proper spacing. Characters are displayed on the screen. It has Wi-Fi so one can upload a text file for practice or connect to the internet Morserino server which hams are using for practice gso's with their Morserinos. Lately I have been

using the newest Morserino tool created by John, MOSTQ, to do QSOs with a Bot.

Building the kit is easy as it consists of just adding the larger components to an already completed surface mount pcb and the instructions are great. Here is a picture of my Morserino-32 with battery cable to lipo battery on bottom shelf:

Ingrid, W7SIG/D07ISG: My husband, Reinhard, DL1UF, and I traveled to Germany earlier this year as we were looking forward to celebrating our Silver Wedding Anniversary in the church where we married in the mountain village of Schellerhau 25 years ago. Reinhard was born very close to this 400-year old Lutheran church. It has been the church of his maternal ancestors over many generations and the place where relatives are buried nearby. The village of Schellerhau is located in the Erzgebirge, the Ore Mountains, south of Dresden and only about four miles north of the Czech border. On March 11th, the spread of the infectious disease Covid-19 was classified as a pandemic and a few days later a law to protect the German population in the event of an epidemic came into force and we had no other choice but to call off our plans. We remained mainly at our place in Schmiedeberg, in the Ore Mountains of Saxony. Understanding the situation, our friends, Norbert, DL4DTU, and his YL Sylve, DL3DTS, offered us an amateur radio satellite ground station to sweeten our stay at home. Dieter, DM5CF, loaned us a laptop, and Siegfried, DL3VZL, quickly came to install Logger32, the logging program that is favored at the nearby club station, DL0ERZ. Norbert, DL4DTU, is the regional VHF/UHF/EME guru and provided us in Arizona with great 24 GHz equipment in the past, which gave me the chance for my first 24 GHz OSO with Charlie, W7GBI, several years ago in the mountains west of Flagstaff. It was a new and fascinating experience for me to be able to have very interesting conversations via the geostationary satellite Oscar-100. Not only did I make my first contact using contacts in over 50 countries. Hams were simply delighted to work a YL and I was just thrilled to have a YL to YL contact with Marion, OE25YSC, (OE3YSC) who was using a special-event call-sign in recognition of Austria's 25 years EU membership. Oscar-100 was launched two years ago and orbits 35,786 km (22,236 miles) above the Equator over Central Africa. The satellite appears to be stationary, which allows the antenna to be permanently pointed to a fixed location in the sky. We used a 90 cm dish for the 2.4 GHz up-link and 10 GHz down link and just a few watts were sufficient to produce a good signal. The footprint of the satellite makes contacts from Brazil to China possible, but, unfortunately, doesn't reach North America. However, one can listen to Oscar-100 via WebSDR sites, such as https://eshail.batc.org.uk/nb/ On April 27, we had a Church service with a maximum of 15 people present anyway. The Free State of Saxony opened up a little, just in time to celebrate in a small group. Restaurants, hotels, and businesses were still closed, though.

# Youth

Hello everyone!

This past year has been very historical, to say the least, so in this article, I would like to reflect on a couple of uplifting moments in the past year for youth in Amateur Radio.

Most recently, you've probably heard about YOTA month this past December. I personally participated in the month-long special event coordinated by Carole Perry Educator of the Year award winner Neil Rapp and Bryant Rascoll, KG5HVO. The total contacts for Region Two totaled to be 14,600! Overall, it was a great experience, being able to make contacts all over the globe, it gives a great experience to young operators in working big pile-ups! Also, stay tuned for information for the Region 2 YOTA Camp if you are an interested youth!

Back in Fall, I had the opportunity to meet Linda Mison, DC1CDY/W4LRM, from Buford, GA. She told me all about an all Girl Scout amateur radio group in Manila, Philippines, that she had helped to found and still contributes to today. I became very interested in them, so I've been in contact with one of their members, Danica Brillantes, to ask about their group and to learn more.

The Manila Girl Scout Council Amateur Radio Club (MGSC ARC), DX1MGS, was founded by Linda



Mison, DC1CDY/W4LRM, along with the Philippines Ham Radio Training Society (now the Philippines Scouts Ham Amateur Radio Enthusiasts for Service) in 1979. The membership consists mainly of upper-level Girl Scouts from ages 14-18 who work under the supervision of a licensed amateur radio operator. The main purpose of the group is to bring together the teachings and morals of the Girl Scouts into ham radio to help serve a pur-

pose to their community as well as help the girls become educated in this STEM activity. Danica also informed me that they help girls to overcome their insecurities with ham radio, stating that "A hobby cannot be easily learned overnight. It requires constant practice of communication. With our constant

support, teaching, and training programs we are able to help these Girl Scouts overcome the insecurities and problems they face, allowing personality development, and self-growth." This is important and should be a lesson to the rest of the world on how to involve and attract more women and youth into amateur radio! Continually supporting new members of ham radio will allow them to built an interest that lasts a lifetime, rather than fading a few months after passing their test. One of the Girl Scouts, Micah Magusib, explains that she became initially interested in Amateur Radio when she attended the Girl Scout of the Philippines "International Friendship Exchange and DX Contest" (INFEX) in 2017, had to unexpectedly jump in due to limited participants and became hooked! She states that "I became



more active and devoted in learning many things about Amateur Radio such as how to handle radio equipment and how to [call a net]."

The other girls also had some interesting stories on how they became interested in ham radio, Girl Scout Raphaelle Sereña explained that she "enjoyed the adrenaline rush during competitions and it was fun getting to talk with people located in other countries." and Girl Scout Judessa Baldia, 4G1DES, said that "I overcame the challenges and struggles that I experienced when I was a newbie in amateur radio, where I met new friends." Overall, the girls seem to be loving ham radio, and I hope that Amateur radio groups here in the US will see that what youth want in ham radio is to have fun, find friends, and become a part of something bigger than themselves.

# Rules for All YLRL Contests

- 1. Check to make certain you are sending logs to the CURRENT Vice-President.
- 2. Logs must be postmarked no later than 30 days after each contest ends.
- 3. Scoring:
- 4. Phone and CW contests will be scored separately. Separate logs must be submitted for each contest.
- 5. One point is earned for each different station worked on each band. The same station may be worked on different bands. In the YL-OM contest only, YLs count OMs and OMs count YLs.
- 6. Multiplier will be the ARRL sections and/or DX countries, whichever is appropriate. Canadian provinces are counted individually. Multipliers are used only once on all bands when figuring the score.
- 7. Contestants running 5W or less will be considered QRP and earn a power factor of 3. Contestants running 5W to 100W will be considered low power and earn a power factor of 1.5. Contestants running over 100W will be high power. If no transmitter power is listed on logs, no power factor will be given.

Total scored claimed is calculated by multiplying the points times the multiplier times the power factor.

# Logs

- 1. All logs must show the operator's ARRL section, VE province, or country to qualify for awards. Where applicable, logs must state whether or not the operator is a member of YLRL. For each QSO, logs must also state the power output. If you have 200 or more QSOs, submit a separate log for each band and submit a "dupe" sheet.
- 2. Please type or print. If you print a log from a logging program or photocopy your log book, be sure they include all the required information.
- 3. Logs must be signed and show claimed score. No logs will be returned. Entries in log must also show time, band, date and transmitter power.

# **ELIGIBILITY**

All licensed men and women operators throughout the world are invited to participate.

### **PROCEDURE**

OMs call "CQ-YL" and YLs call "CQ-OM."

# **OPERATION**

All bands may be used except WARC bands. Net contacts and repeater contacts do not count. Participants may work only 24 hours of the 36 hours in each contest. Operating breaks should be indicated in the log.

# **EXCHANGE**

Station worked, QSO number, RS(T), ARRL section, VE province, or country. Entries in the log should indicate time, band and date.

# **SCORING**

- (1) Phone and CW will be scored as separate contests. Digital contacts count as CW. Score each band separately.
- One point is earned for each different station worked on each band; YLs count only OMs and OMs count only YLs. Add together the QSO points earned for each band.
- Multiply the number of QSOs by the total number of different ARRL sections/VE provinces/countries worked. A multiplier is counted only once in each mode (ie SSB, CW). Contestants running 5W or less will be considered QRP and earn a power factor of 3.
- Contestants running 5W to 100W will be considered low power and earn a power factor of 1.5. Contestants running over 100W will be high power. If no transmitter power is listed on logs, no power factor will be given.

# LOGS

All logs must how your ARRL section, province, or country to qualify for awards. For each QSO, logs must show the station worked, QSO number given and received, RS(T) given and received, the ARRL section, VE province, or country of the station worked, time, band, and date. Logs must also state the power output used and the operating breaks taken. If you have 200 or more QSOs, submit a separate log for each band and submit a "dupe" sheet. Remember to file separate logs for each contest. Logs must show claimed score. All logs go to the current YLRL Vice President and must be submitted within 30 days of contest ends.

# YLRL CONSTITUTION As amended January 2020 new date

# **ARTICLE I - NAME**

This Corporation shall be known as the YOUNG LADIES' RADIO LEAGUE, INC., hereafter referred to as the League or as YLRL.

# **ARTICLE II - PURPOSES**

The purposes of the Corporation shall be:

- A. To encourage and assist Young Ladies (YLs) throughout the world to enter into the Amateur Radio Service.
- B. To sponsor, and otherwise carry out programs to promote YL interest, appreciation, and understanding of radio communications and electronics, and to encourage them to advance and improve their skills as Amateur Radio operators.
- C. To carry out a program of specialized service to blind and otherwise handicapped Young Ladies. to Young Ladies with disabilities.
- D. To provide Scholarship funds or other grants to worthy-eligible Young Ladies to continue their education, with preference given to those in the academic study of communications and electronics or related arts and sciences.
- E. To host foreign international YLs during their visits to the United States and to sponsor their participation in YLRL activities.
- F. To encourage Amateur Radio competition between YLs by offering certificates, trophies, etc., for demonstrated excellence in such operating competitions.certificates and awards for demonstrated excellence in operating competitions.

### **ARTICLE III - MEMBERSHIP**

- **Section 1** For the purposes of this Corporation, the term Young Lady (YL) is defined as meaning a woman of any age who holds an Amateur Radio license.
- **Section 2** Membership in the YOUNG LADIES' RADIO LEAGUE, INC. shall be open to any woman who submits satisfactory proof that she holds an Amateur Radio license issued by the U. S. Federal Communications Commission or the equivalent foreign authority. Continued membership in the League is determined by this license.
- **Section 3** Membership in the League shall consist of the following:
  - A. FULL MEMBERS who shall be entitled to all rights and privileges of the League.

- B. FAMILY MEMBERS who shall be entitled to all rights and privileges of the League except for receiving the official publications.
- C. ASSOCIATE MEMBERS who shall be entitled to all the rights and privileges of the League except the right to hold office.
- D. LIFE MEMBERS who shall be entitled to all the rights and privileges of the League.
- E. HONORARY MEMBERS who shall be entitled to all the rights and privileges of the League except the right to vote or hold office.

# **ARTICLE IV - OBJECTIVES**

- **Section 1** The YOUNG LADIES' RADIO LEAGUE, INC. shall operate exclusively for charitable, educational, and scientific purposes, entitling it to exemption under the provisions of Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended.
- **Section 2** No part of the income of the Corporation shall inure to the benefit of, or be distributable to any member, officer, or director of the Corporation (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its stated purposes set forth in ARTICLE II), and no member, officer or director of the Corporation or any private individual shall be entitled to share in the distribution of any of the Corporation's assets on dissolution of the Corporation.
- **Section 3** The private property of the incorporators, members, officers or directors of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever.
- **Section 4** Nothing herein shall authorize this Corporation, directly or indirectly, to engage in, or include among its purposes any of the activities mentioned in Not-for-profit Corporation Law, Section 404 (b) (p) of Executive Law, Section 757.
- **Section 5** No part of the activities of the Corporation shall include participation in or intervening in (including the publication or distribution of statements for) any political campaign on behalf of any candidate for public office or engaging in any substantial way, directly or indirectly in carrying on propaganda or otherwise attempting to influence legislation.
- **Section 6** In the furtherance of its corporate purposes, the Corporation shall have all general powers enumerated in Section 202 N-PCL, together with the power to solicit grants and contributions for corporate purposes.
- **Section 7** The Corporation shall distribute its income for each taxable year at such time and in such manner as not to subject it to tax under Section 4942 of the Internal Revenue Code of 1954, as amended, and the Corporation shall not:
  - A. Engage in any act of self-dealing as defined in Section 4941 (d) of the Code;
  - B. Retain any excess business holdings as defined in Section 4943 (c) of the Code:
  - C. Make any investments in such manner as to subject the Corporation to tax under Section 4944 of the Code; or
  - D. Make any taxable expenditure as defined in Section 4945 (d) of the Code.
- **Section 8** In the event of dissolution of the Corporation, and after payment of all necessary expenses and obligations thereof, any remaining assets shall be distributed to such organizations having an exempt purpose similar or analogous to that of this Corporation and which shall at the time qualify as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code.

# **ARTICLE V - ORGANIZATION**

**Section 1** For the purposes of organization and Corporation activities, there shall be a division of the organization according to the United States amateur call sign areas and such additional districts as are deemed desirable by the Board of Directors.

**Section 2** The fiscal year and membership year shall begin on January 1.

# **ARTICLE VI - OFFICERS**

**Section 1** Officers of the Corporation, hereafter referred to as "the League", shall consist of the following: President, Vice-President, Secretary, Receiving Treasurers, and Disbursing Treasurer.

**Section 2** At the time of election of officers, there shall be elected one District Chairwoman from each of the YLRL Districts.

**Section 3** Only full, family, or life members who have been members in good standing for at least two consecutive years immediately prior to taking office shall be eligible to hold office as defined in Sec. 1 of this Article, or one year in the case of District Chairwomen.

# **ARTICLE VII - ELECTION OF OFFICERS**

**Section 1** All officers and District Chairwomen shall be elected by the membership for a term of two years. They shall take office at the beginning of the membership year following their election and each shall hold office until her successor has assumed the duties of office.

**Section 2** Election of all officers and Chairwomen shall be in accordance with the regulations prescribed in ARTICLE X of the By-Laws.

**Section 3** Simple plurality vote shall govern in all elections of officers.

## **ARTICLE VIII- MEETINGS**

Section 1 All "meetings" will normally be conducted by mail or email.

**Section 1** All meetings will normally be conducted by mail, email, or other electronic means.

**Section 2** No regular membership meetings are specified.

**Section 3** Action of the Board of Directors shall be called by the President at least twice a year; one meeting being near the end of the membership year.

# ARTICLE IX - AMENDMENTS

The Constitution or By-Laws may be amended by membership vote, with a two-thirds majority of the total votes cast being required.

# YLRL BY-LAWS As amended January 2020 new date

# <u>ARTICLE I – MEMBERSHIP</u>

**Section 1** Pursuant to ARTICLE III of the Constitution, the following membership requirements are established:

A. FULL MEMBERSHIP shall be open to all women who possess a valid renewable Amateur Radio license issued by the U.S. A. or Canada.

B. FAMILY MEMBERSHIP shall be open to Full Members residing at the same address.

C. ASSOCIATE MEMBERSHIP shall be open to all women who meet the general membership qualifications but who reside outside the U.S.A. and its possessions or Canada.

D. LIFE MEMBERSHIP shall be granted to licensed women Amateur Radio operators who may be elected thereto by formal action of the League.

E. HONORARY MEMBERSHIP shall be granted to those individuals who may be elected thereto by formal action of the League.

Section 2 Application for membership shall be submitted in writing by mail, email, or other electronic means to a Receiving Treasurer. Each applicant must express her willingness to abide by the Constitution and By-Laws and such rules as may from time to time be promulgated.

Section 3 Expiration of amateur license or equivalent foreign authorization shall automatically disqualify a person from membership. However, the YL shall be entitled to receive YL Harmonics as a subscriber for the remainder of the membership year for which her dues were paid.

Section 4 Expulsion from membership shall be in accordance with the provisions of Roberts' Rules of Order. Such action may be taken if a member fails to renew her license. or for non-payment of dues.

# **ARTICLE II - DUES**

**Section 1** The annual dues shall be as follows:

A. FULL MEMBER \$15.00
B. FAMILY MEMBER 3.00
C. ASSOCIATE MEMBER 15.00
D. LIFE MEMBER 0.00
E. HONORARY MEMBER 0.00

All dues are payable in U.S.A. funds or their equivalent amount based on the current rate of exchange.

Section 2 Members and subscribers not eligible or not desiring to receive YLH by bulk mail shall be charged an additional amount to cover first class or air mail postage for mailing the League publications. Members and subscribers wishing to receive the official YLRL publication known as YL-Harmonics (YLH) by mail may be charged an additional amount to cover first class or air mail postage. This additional amount shall be determined by the Board of Directors upon recommendation of the Disbursing Treasurer, Budget & Finance Committee, and the Publications Committee. Majority of the votes cast shall be required.

Section 3 Dues for renewal of continuous membership shall be paid in advance, shall be due and payable on January 1<sup>st</sup> of each year and shall become delinquent if not paid by March 31<sup>st</sup> of that year.

Section 4 For new and reinstating members joining after June 30<sup>th</sup>, the dues may be prorated by half the annual dues for that fiscal year.

**Section 5-4** Members who fail to pay their dues by March 31<sup>st</sup> shall be considered delinquent, and shall be dropped from the rolls. The Receiving Treasurers shall notify said delinquent member of this action by first class mail or email sent to the delinquent member's last address of record or current-call-book call sign listing.

**Section 6 5** A former member whose name has been dropped from the rolls for a period of less than one membership year shall have the balance of that membership year as a grace period. If, before the end of her grace period, the lapsed member pays dues for that full year, her name shall be restored to the rolls, there shall be no break in her membership continuity, and she shall regain her good standing. if she pays the prorated amount of the dues, she shall forfeit her membership continuity.

**Section 76** A former member who has been dropped from the rolls for a period exceeding one membership year may rejoin on the same basis as a new member. Her membership continuity shall be considered broken for the year(s) or portions thereof in which her dues were unpaid and she was not a member. She shall be called a reinstated member.

Section 8 Dues may not be paid for more than one year in advance, except when a reinstatement—or a new member's application is accepted on a prorated basis, and then she may include dues for the—following year. In the event the membership year is changed, dues may be paid to cover through the—period of the next full membership year.

**Section 7** Dues may be paid either for one year or for three years.

# **ARTICLE III - OFFICERS**

**Section 1** The officers of the League shall be elected for a term of two years. They shall assume office on January 1<sup>st</sup> of the year following their election.

**Section 2** The President and Vice-President shall not be eligible to succeed themselves. (This does not mean that they cannot run for ANOTHER office - only that they cannot hold the office of President or Vice-President for more than two consecutive years.)

**Section 3** No member shall hold more than one elective office at any one time.

**Section 4** A vacancy in the President's office before the expiration of term shall be filled by the Vice-President. Should both the President and Vice-President be unable to act, the Secretary shall notify the Board of Directors who shall then designate an Acting President. Vacancies other than that of President occurring between elections shall be filled by appointment of the President under whom that officer shall serve.

**Section 5** All officers shall serve without compensation in any form. This shall not preclude reimbursement of necessary expenses incurred in the conduct of their respective offices and approved by the Board of Directors.

**Section 6** Should an officer or District Chairwoman fail to carry out their duties adequately, the person holding that position may be removed from that position by a two-thirds vote of the Board of Directors.

# **ARTICLE IV - DISTRICT CHAIRWOMEN**

**Section 1** Election of District Chairwomen shall be made at the same time and on the same ballot as the election of primary officers.

**Section 2** All regulations regarding eligibility (ARTICLE VI, Sec. 3 of Constitution) and election of officers shall apply, except that members shall vote for only one District Chairwoman to represent the district in which the member resides, and except that Receiving Treasurer DX shall be elected by all members except Honorary Members.

## **ARTICLE V - BOARD OF DIRECTORS**

The Board of Directors shall consist of the President, Vice-President, Secretary, Receiving Treasurers, Disbursing Treasurer, District Chairwomen, Chairwomen of each of the Standing Committees, all appointed positions, and the immediate Past President of YLRL.

## ARTICLE VI - EXECUTIVE BOARD

The Executive Board shall consist of the President, Vice-President, Secretary, Receiving Treasurers, and Disbursing Treasurer, who shall have all the powers of the Board of Directors between the meetings of that Board. The Board of Directors shall define in broad terms the duties and authority of the Executive Board.

# **ARTICLE VII - DUTIES OF OFFICERS**

Section 1 The President shall preside at all official meetings and/or conventions of the League and shall act as Chairwoman of the Board of Directors. She shall be an ex-officio member of all Standing Committees. She shall call meetings of the Board by mail, email, or other electronic means at least twice a year. She shall make all appointments whenever vacancies occur in offices. She shall retain the corporate seal and shall affix it to all Certificates and/or Awards she signs. The President shall appoint one of the District Chairwomen to serve as Chairwoman of the Nominating Committee during her first year in office and no later than July of that year.

Section 2

- **A.** The Vice-President shall assume all duties of the President in the absence or disability of the latter. She will work with the Receiving Treasurer US to receive electronic funds and forward the money to the Disbursing Treasurer and Scholarship Chairwoman as appropriate. She shall have charge of all League station activities, contests, rules of same, nets, etc., with the exception of the League Club call-call sign K4LMB. In this work she will be assisted by a committee of at least three members, preferably Past Vice Presidents, of her choice, each from a different district. She shall appoint a custodian for awards such as WAS/YL, YLCC, WAC/YL, DX/YL, and DX/YLCC and Continuous Membership Certificate. She may appoint committees or assistants to aid her in specific branches of activities under her jurisdiction. She shall serve as a member of the Board of Directors.
- **B.** Rules governing the issuance of YLCC, WAS/YL, WAC/YL, DX/YL and the DX/YLCC certificates may only be changed or amended by following the procedures for Constitution and By-Laws changes set forth in ARTICLE XV, Section 1 of the By-Laws.
- **C.** Major changes relating to YLRL contests shall be handled as follows: The proposed change shall be first sent to the current Vice-President of YLRL and the current Vice-President's Advisory Committee for discussion and opinion. If their approval is forthcoming, the proposal shall be sent to the Board of Directors for vote. A majority vote by this Board shall make the change effective immediately.

**Section 3** The Secretary shall keep a record of all proceedings of the League. She shall keep a complete and accurate record of amendments to the Constitution and By-Laws. She shall maintain a file of all new applications for membership for one year and shall handle all matters pertaining to membership and voting in accordance with the provisions of the By-Laws and Procedure Policy. She shall mail or email to each new member a letter of welcome. She shall serve as a member of the Board of Directors.

# Section 4

**A.** The Receiving Treasurers shall receive all money for dues and forward this money to the Disbursing Treasurer. They shall send a dues receipt to each member. They shall forward all new applications for membership to the Secretary for her files and shall keep the Secretary, Continuous Membership Chairwoman, Database Manager and Editor advised of dues payment and of all changes in the membership records. The Receiving Treasurer US will work with the Vice-President to receive electronic funds and forward this money to the Disbursing Treasurer and Scholarship Chairwoman as appropriate. They shall serve as members of the Board of Directors.

**Section 5** Each District Chairwoman, the Youth Chairwoman and Receiving Treasurer DX shall be responsible for gathering news for <u>YL Harmonics</u> and forwarding same to the Editor at appropriate intervals. She shall assist the Vice-President in <del>organizing contests, traffic schedules, nets, and</del> all League activities. She shall serve as a member of the Board of Directors.

**Section 6** The Board of Directors shall be responsible for all matters of League policy. The Board shall be called to meet at least twice a year, one meeting being near the close of the club year. Additional meetings may be called by the President at her discretion or by a written request of three or more members of the Board. All business of the Board will normally be handled by mail or email.

**Section 7** The Executive Board shall act for the Board of Directors when necessary between meetings of the Board of Directors.

# **ARTICLE VIII - STANDING COMMITTEES**

**Section 1** The Standing Committees of the League shall consist of the following: PUBLICATIONS, PUBLICITY, BUDGET & FINANCE, AFFILIATED CLUBS, and WEBSITE.

**Section 2** The Publications Committee shall edit a publication to be known as <u>YL Harmonics</u>. The policy of the publication shall be determined by the board of Directors and the Editor. The general management of this publication shall be in the hands of the Editor who shall be Chairwoman of this Committee.

Section 3 The Publicity Committee shall be responsible for publicizing the League in every way possible. It shall provide news items concerning the League and/or its members to newspapers, magazines, and social media. The Publicity Committee shall maintain the accounts for the various YLRL social media sites, such as Facebook, Twitter, Instagram, etc. It shall cooperate with the District Chairwomen in all publicity work and aid them whenever requested. The Publicity Committee shall maintain a League Scrapbook and a Photo Album which shall be sent upon request to Affiliated Clubs or conventions.

Section 4 The Budget & Finance Committee shall act as advisor to the Board of Directors. It shall advise the Board in regard to investing League funds. It shall act as advisor to the Disbursing Treasurer. The Budget & Finance Committee shall appoint two members who shall be approved by the Executive Board to serve as auditors for an annual audit. These members should have some experience with finances.

**Section 5** The Affiliated Clubs Committee shall act as liaison between YLRL and affiliated YL radio clubs. See ARTICLE XIII Affiliated Clubs.

Section 6 The Supplies Chairwoman will work closely with the Disbursing Treasurer since she will handle funds from the sale of pins, charms, etc. She will maintain other supplies for distribution to the officers in the conduct of their respective offices.

**Section 6** The Supplies Chairwoman will work closely with the Disbursing Treasurer since she will handle funds from the sale of YLRL merchandise.

**Section 7** The Website Committee will be in charge of the YLRL website, working with the web-mistress to ensure that all information is up-to-date and in line with all club policies.

# **ARTICLE IX - VOTING**

**Section 1** On questions involving the entire membership, the Secretary shall provide each member with a ballot and information concerning the question or candidate to be voted on. This may be done through publication in <u>YL Harmonics</u>, provided each Family Member shall also receive a copy of the ballot. A closing date for voting shall be stated in the notice and shall be not less than six weeks from the date the notice is mailed.

Section 2 Ballots shall be returned to the Secretary in an envelope signed by the voting member. Ballots shall be signed by the voting member and returned to the Secretary by mail, email, or other electronic means. The Secretary shall verify the eligibility of each voter, shall count and tabulate the votes, and submit them to an auditor designated by the Board of Directors. After auditing, if there are no discrepancies, the votes shall be returned to the Secretary for retention. If there is a discrepancy between the count of the Secretary and that of the auditor, the ballots shall be forwarded to the President for final decision. The Board of Directors shall direct the Secretary to send written notice of election results to all candidates and shall cause the results of the balloting to be published in the next regular issue of YL Harmonics.

**Section 3** On ballots involving the entire membership, a simple plurality of votes cast shall govern in all matters except amendment of the Constitution and By-Laws, which shall require a two-thirds majority of the votes cast.

**Section 4** On ballots of the Board of Directors, a majority of the votes cast shall govern in all matters.

# **ARTICLE X - ELECTIONS**

**Section 1** During her first year in office, and no later than July of that year, the President shall appoint one of the District Chairwomen to serve as Chairwoman of the Nominating Committee. The Chairwoman shall then appoint two more District Chairwomen to assist her in selecting qualified candidates for each of the offices stipulated in ARTICLE VI of the Constitution.

**Section 2** In addition to the candidates selected by the Nominating Committee, any qualified member may be nominated for office by written petition of five members in good standing.

**Section 3** No member may be nominated to office without her written consent. Write-in votes will not be allowed.

**Section 4** The Nominating Committee shall check on the eligibility of each candidate and shall cause to be published in <u>YL Harmonics</u>, or in a special bulletin, a slate of candidates for office together with a brief review of each candidate's qualifications.

**Section 5** If there is any office for which there is no candidate, the President under whom she is to serve will appoint a member who qualifies under ARTICLE VI, Sec. 3 of the Constitution.

**Section 6** Prior to July 15, ballots for the general election shall be provided for each member. Ballots may be included in <u>YL Harmonics</u> if desired, provided each family member shall also receive a copy of the ballot.

**Section 7** Voting shall be conducted in accordance with ARTICLE IX of the By-Laws.

# **ARTICLE XI - QUORUM**

The members participating in any meetings of voting shall be considered a quorum, providing all members have been notified of the activity by mail or email sent to the last address of record. Such notice shall be mailed at least six weeks prior to the closing date of the ballot.

### **ARTICLE XII - LEAGUE PAPER**

**Section 1** There shall be an official publication of the YLRL to be known as <u>YL Harmonics</u> which shall be published by the Publications Committee in accordance with the provisions of ARTICLE VIII, Sec. 2. A copy of <u>YL Harmonics</u> shall be supplied to every member of the League in good standing with the exception of Family Members.

**Section 2** The expenses of <u>YL Harmonics</u> shall be governed by the Board of Directors.

Section 3 Subscription to <u>YL Harmonics</u> may be obtained by any interested persons upon payment of a subscription fee of \$15.00 per year, plus any additional postage required. Subscriptions shall run from January 1<sup>st</sup> to <del>January 1<sup>st</sup></del>. December 31st.

# **ARTICLE XIII - AFFILIATED CLUBS**

**Section 1** Local clubs of women radio amateurs shall be eligible for YLRL Affiliated Club Membership when 50% of the licensed members of such club are YLRL members in good standing. Written application for affiliation shall be made to the Affiliated Clubs Chairwoman, accompanied by a designation of the geographical area covered. A certificate of affiliation shall be issued by the YLRL Secretary.

**Section 2** Affiliation of the YLRL Affiliated Clubs shall be renewable at the beginning of the YLRL membership year and shall require submission of an affirmation of eligibility.

**Section 3** YLRL Affiliated Clubs shall be independent organizations and shall pursue no course of action in the name of YLRL without first obtaining written permission of the Executive Board. If the name "Young Ladies' Radio League" or "YLRL" is incorporated in the name of the club, it shall be qualified as to location or territory served by the local club.

**Section 4** Any action or policy pursued by an Affiliated Club which is in opposition to the Constitution or policy of YLRL shall be cause for cancellation of affiliation within the discretion of the Board of Directors.

# **ARTICLE XIV - SCHOLARSHIP FUND**

The Young Ladies' Radio League, Inc. shall establish a scholarship fund to provide scholarships or other grants to worthy eligible Young Ladies for continuing their education, with preference given to those in the academic study of communications and electronics or related arts and sciences.

# **ARTICLE XV - AMENDMENTS**

**Section 1** An amendment to the Constitution or By-Laws may be proposed at any time by written request of five or more members. Such proposal shall be submitted to the Board of Directors who shall give it consideration, and if approved, shall cause the proposed amendment together with appropriate ballot and reasons for the proposal to be published in the next regular issue of <u>YL Harmonics</u>, or by special bulletin. Voting shall be conducted in accordance with the provisions of ARTICLE IX of the By-Laws. Approved amendments shall be recorded by the Secretary.

**Section 2** On questions of order and procedure not otherwise determined by these By-Laws, the provision of the current editions of Roberts' Rules of Order shall prevail.

Section 3 The present By-Laws shall become effective January 2020 new date.
