# PRESIDENT'S MESSAGE

Many of you have asked about a directory issue. Here it is! It is pretty much call book style, but there wasn't space or time to compile one with all the information such as the last one had. However, calls, names and addresses are most important and they are here.

After a long talk with some of the past presidents and members of the Executive Board, we have decided to retire the "Copper Plaque" Corcoran Award. This award was established in 1959 by Marie and Corky Corcoran and through the years has become scratched, dented, stained, and in general not too attractive. We have issued to all winners since 1959 a permanent wall plaque to replace the award. This award will be continued as a YLRL award, but will retain the Corcoran Award name in deference to the generosity of the Corcorans in the past. From now on the award will be a 4x6" walnut plaque with a gold plate with the designation of the year and winner. Rather than having to win three times to keep the award, each year's winner will be awarded this plaque and will retain it permanently.

**ELIGIBILITY:** All licensed women operators throughout the world are invited to participate. YLRL members only are eligible for the cup awards. Non-members will receive certificates. ONLY YLRL MEMBERS are eligible for the Corcoran Award. Contacts with OMs will not count.

**OPERATION:** All bands may be used. Cross band operation is not permitted. Only one contact with each station will be counted in each contest.

**PROCEDURE:** Call "CQ YL".

**EXCHANGE:** Station worked, QSO Number, RS or RST, ARRL Section or country. Log entries should also show the time, band, date, Xmitter, and power used. Please know your own ARRL section. Section list available from Vice Pres. (SASE please) or can be found on page 6 of any issue of QST.

**SCORING:** (a) CW and PHONE sections will be scored as separate contests. Submit separate logs for each contest.

(b) Multiply number of contacts by TOTAL number of ARRL sections and/or countries worked.

(c) Contestants running 150 Watts input power at all times may multiply the results of (b) by 1.25 (Low Power Multiplier.)

(d) SSB contestants running 300 watts P.E.P. or less at all times may use the Low Power Multiplier.

**AWARDS:** Highest CW score (YLRL Member): Gold Cup. Highest Phone score (YLRL Member): Gold Cup. Highest CW and Highest



Phone log from each district and country will receive a certificate. Highest Combined Phone and CW score will receive the Corcoran Award. (See note about new award for this contest.) **DX ONLY:** Highest combined CW and Phone score from North and Central America including the Greater and Lesser Antilles will receive an award from Arlie Hager, W4HLF. Highest Combined score from any other part of the world will also receive this award.

**LOGS:** Copies of all logs must show claimed score, be signed by the operator, and be postmarked no later than November 25, 1966 and be received no later than December 9th, or they will be disqualified. Send logs to:

## YLRL CONSTITUTION, BY-LAWS AND PROCEDURE POLICY—JULY 1, 1966

### CONSTITUTION

We, the undersigned, being desirous of  
furthering cooperation among women radio  
amateurs, developing proficiency in radio oper-  
ation and furthering the interests of amateur  
radio, do hereby constitute ourselves the  
YOUNG LADIES' RADIO LEAGUE and  
enact this constitution as our governing law.

#### ARTICLE I—MEMBERSHIP

Sec. 1. Only Licensed women amateur  
radio operators shall be eligible for member-  
ship.

Sec. 2. Membership of the League shall  
consist of the following:

**FULL MEMBERS** who shall be entitled to  
all the rights and privileges of the league.

**FAMILY MEMBERS** who shall be entitled  
to all the rights and privileges of the league  
except for receiving the official publications.

**ASSOCIATE MEMBERS** who shall be en-  
titled to the rights and privileges of the league  
except the right to hold office.

**LIFE MEMBERS** who shall be entitled to  
all the rights and privileges of the league.

**HONORARY MEMBERS** who shall be en-  
titled to all the rights and privileges of the  
league except the right to vote or hold office.

#### ARTICLE II—ORGANIZATION

Sec. 1. For the purposes of organization  
and League activities, there shall be a division  
of the organization according to the United  
States amateur call sign areas and such addi-  
tional districts as are deemed desirable by  
the Board of Directors.

Sec. 2. The club year shall begin at mid-  
night, EST, December 31.

Sec. 3. The fiscal year shall begin on  
March 1.

#### ARTICLE III—OFFICERS

Sec. 1. Officers of the League shall con-  
sist of the following: President, Vice Presi-  
dent, Secretary, Receiving Treasurer and Dis-  
bursing Treasurer.

Sec. 2. At the time of election of officers,  
there shall also be elected one District Chair-  
man from each of the YLRL Districts.

Sec. 3. Only full, family, or life members  
who have been members in good standing for  
at least two consecutive years immediately  
prior to taking office shall be eligible to hold  
any office.

#### ARTICLE IV—ELECTION OF OFFICERS

Sec. 1. All officers and District Chairmen  
shall be elected by the membership for a term  
of one year. They shall take office at the be-



gining of the club year and each shall hold office until her successor has assumed the duties of the office.

Sec. 2. Election of all officers and chairmen shall be in accordance with the regulations prescribed in ARTICLE X of the By-Laws.

Sec. 3. Simply plurality vote shall govern in all elections of officers.

#### ARTICLE V—MEETINGS

Sec. 1. All "meetings" will normally be conducted by mail.

Sec. 2. No regular membership meetings are specified.

Sec. 3. Action of the Board of Directors shall be called by the President at least twice a year, one "meeting" being near the end of the club (calendar) year.

#### ARTICLE VI—AMENDMENTS

Sec. 1. The Constitution or By-Laws may be amended by membership vote, a two-thirds majority of the total votes cast being required.

### BY-LAWS

#### ARTICLE I—MEMBERSHIP

Sec. 1. Pursuant to Article I of the Constitution, the following membership requirements are established. **FULL MEMBERSHIP** shall be open to all women who possess a valid renewable amateur radio license. **FAMILY MEMBERSHIP** shall be open to the second or additional Full Member of any one family residing at the same address. **ASSOCIATE MEMBERSHIP** shall be open to all women who meet the general membership qualifications but are unable to comply with all the requirements specified for Full Membership. **ADOPTED MEMBERSHIP** shall be granted to those Associate Members residing outside the United States or Canada who are unable to send money for their dues and are therefore "adopted" by YLRL groups or individuals. Women holding Novice Class licenses are eligible for Associate Membership during the term of their Novice License and shall be transferred to Full Membership upon obtaining a renewable license. **LIFE MEMBERSHIP** shall be granted to licensed women amateur radio operators who may be elected thereto by formal action of the League. **HONORARY MEMBERSHIP** shall be granted to those individuals who may be elected thereto by formal action of the League.

Sec. 2. Application for membership shall be submitted in writing to the Receiving Treasurer and must be endorsed by a member in good standing. Each applicant must express her willingness to abide by the Constitution and By-Laws and such rules as may from time to time be promulgated.

Sec. 3. Election procedure shall be as follows: Application for membership shall be submitted to the Board of Directors. A majority vote by the Board shall elect to membership. The Board may delegate ministerial functions of granting membership where no question of eligibility or desirability is raised.

Sec. 4. Expiration of amateur license shall automatically disqualify a person from membership. However, the YL shall be entitled to receive Harmonics for the remainder of the fiscal year for which her dues were paid.

Sec. 5. Expulsion from membership shall be in accordance with the provisions of Roberts' Rules of Order.

#### ARTICLE II—DUES

Sec. 1. The dues shall be as follows:

FULL MEMBER .....	\$3.00
Except Family member .....	\$1.25
ASSOCIATE MEMBER .....	\$3.00
Novice Member .....	\$3.00
Adopted Member .....	\$3.50
SUBSCRIBER .....	\$3.00
LIFE MEMBER SHALL PAY NO DUES.	

HONORARY MEMBER SHALL PAY NO DUES.

Sec. 2. Members and Subscribers who reside outside the continental United States or Canada shall be charged an additional amount to cover the cost of foreign postage or air mail required for mailing the League publications.

Sec. 3. Dues shall be paid in advance and shall be due and payable on March 1st of each year.

Sec. 4. For members joining at other than the beginning of the fiscal year the dues shall be prorated on a quarterly basis.

Sec. 5. Dues may not be paid for more than one year in advance except for the partial payment of new membership. In the event the fiscal year is changed, dues may be paid to cover through the next full fiscal year.

Sec. 6. Special assessments may be levied upon the membership by a vote of the Board of Directors.

Sec. 7. Notice of expiration of dues shall be published in the YL Harmonics magazine. Delinquent members shall then be notified by first class mail after March 31st.

Sec. 8. Members who fail to pay their dues within a period of one month subsequent to the date on which they become due and payable shall be automatically dropped from membership provided that notification of such action has been given in the expiration notice or by a letter sent first class mail to the last address of record.

#### ARTICLE III—OFFICERS

Sec. 1. The officers of the League shall be elected for a term of one year. They shall assume office on January 1st of the year following their election.

Sec. 2. The President and Vice President shall not be eligible for more than one term of office consecutively. (This does not mean that they cannot run for ANOTHER office—only that they cannot succeed themselves in the SAME office)

Sec. 3. No member shall hold more than one office at any one time.

Sec. 4. A vacancy in the President's office before the expiration of term shall be filled by the Vice President. Other vacancies occurring between elections shall be filled by appoint-



ment of the President under whom that officer shall serve.

Sec. 5 All officers shall serve without compensation in any form. This shall not preclude the reimbursement of necessary expenses incurred in the conduct of their respective offices and approved by the Board of Directors.

#### ARTICLE IV—DISTRICT CHAIRMAN

Sec. 1 Election of District Chairmen shall be made at the same time and on the same ballot as the election of primary officers. All regulations regarding eligibility and election of officers shall apply except that members shall vote for only the one District Chairman to represent the District in which the member resides.

#### ARTICLE V—BOARD OF DIRECTORS

Sec. 1 The Board of Directors shall consist of the following: The President, Vice President, Secretary, Receiving Treasurer, Disbursing Treasurer, the District Chairmen, the Chairmen of each of the Standing Committees and the immediate Past President of YLRL.

#### ARTICLE VI—EXECUTIVE BOARD

Sec. 1 The Executive Board shall consist of the Vice President, the Secretary, Receiving Treasurer, Disbursing Treasurer, and the President, who shall have all the powers of the Board of Directors between the "meetings" of that Board. The Board of Directors shall define in broad terms the duties and authority of the Executive Board.

#### ARTICLE VII—DUTIES OF OFFICERS

Sec. 1 The President shall preside at all official meetings and/or conventions of the League and shall act as Chairman of the Board of Directors. She shall be an ex-officio member of all Standing Committees. She shall call meetings of the Board by air or in writing at least twice a year. Prior to taking office on January 1st, she shall appoint one of the newly elected District Chairmen to serve as Chairman of the Nominating Committee. She shall make all appointments whenever vacancies occur in office.

Sec. 2A. The Vice President shall assume all duties of the President in the absence or disability of the latter. She shall have charge of all League station activities, contests, rules of same, nets, etc. In this work she will be assisted by a committee of at least three members of her choice, each from a different district. She shall appoint a custodian for awards such as WAS/YL; YLCC; WAC/YL; DX and Continuous Membership Certificate. She may appoint committees or assistants to aid her in specific branches of activities under her jurisdiction. She shall serve as a member of the Board of Directors.

Sec. 2B. Rules governing the issuance of YLCC, WAS/YL, WAC/YL, and the DX-YL certificates may not be changed or amended except as set forth in Article XIV, Section 1 of the By-Laws.

Sec. 3. The Secretary shall keep a record of all proceedings of the League. She shall keep a complete and accurate record of amendments to the Constitution and By-Laws. She

shall maintain a permanent file of all applications for membership and shall handle all matters pertaining to membership and voting in accordance with the provisions of the By-laws and Procedure Policy. She shall mail to each new member a letter of welcome. She shall serve as a member of the Board of Directors.

Sec. 4A. The Receiving Treasurer shall receive all money for dues and forward this money to the Disbursing Treasurer. She shall send dues receipt cards to each member. She shall forward all applications for membership to the Secretary for her files and shall keep the Secretary and Editor advised of dues payments and of all changes in the membership records. She shall serve as a member of the Board of Directors.

Sec. 4B. The Disbursing Treasurer shall receive and receipt all money sent to her by the Receiving Treasurer and all other money paid to the League, and shall make payment of all obligations known to her to be proper and authorized. She shall submit an itemized financial statement semi-annually to the Budget and Finance Committee for auditing. She shall file all reports required by the Federal, State and local governments. She shall serve as a member of the Board of Directors and shall be an ex-officio member of the Budget and Finance Committee.

Sec. 5. Each District Chairman shall be responsible for gathering news for YL Harmonics and for forwarding same to the Editor at appropriate intervals. She shall assist the Vice President in organizing contests, traffic schedules, nets and all League activities. She shall serve as a member of the Board of Directors.

Sec. 6. The Board of Directors shall be responsible for all matters of League policy. The Board shall be called to meet at least twice a year, one meeting being near the close of the club (calendar) year. Additional meetings may be called by the President at her discretion or by a written request of three or more members of the Board. All business of the Board will normally be handled by mail.

Sec. 7. The Executive Board shall act for the Board of Directors when necessary between meetings of the Board of Directors.

#### ARTICLE VIII—STANDING COMMITTEES

Sec. 1. The Standing Committees of the League shall consist of the following: PUBLICATIONS COMMITTEE, PUBLICITY COMMITTEE, BUDGET & FINANCE COMMITTEE and MEMBERSHIP COMMITTEE.

Sec. 2. The Publications Committee shall edit a publication to be known as YL HARMONICS. The policy of the publication shall be determined by the Board of Directors and the Editor. The general management of this publication shall be in the hands of the Editor who shall be Chairman of the Committee.

Sec. 3. The Publicity Committee shall be responsible for publicizing the League in every way possible. It shall provide news items concerning the League and/or its members to newspapers and magazines. It shall cooperate with the District Chairmen in all publicity work and aid them whenever requested. The



Publicity Committee shall maintain a League Scrap Book and a Photo Album which shall be sent upon request to affiliated clubs or conventions.

Sec. 4. The Budget & Finance Committee shall act as advisor to the Board of Directors to prescribe the amount of money to be expended for specific purposes such as publications of YL Harmonics; operating expenses of individual officers and committees. It shall advise the Board in regard to investing League funds. It shall act as advisor to the Disbursing Treasurer and shall audit the Disbursing Treasurer's reports semi-annually.

Sec. 5. The Membership Committee shall be responsible for recruiting members for YLRL.

#### ARTICLE IX—VOTING

Sec. 1. On questions involving the entire membership, the Secretary shall provide each member with a ballot and information concerning the question or candidate to be voted on. This may be done through publication in YL HARMONICS, provided each Family Member shall also receive a copy of the ballot. A closing date for voting shall be stated in the notice and shall not be less than six weeks from the date of publication.

Sec. 2. Votes shall be returned to the Secretary in an envelope signed by the voting member. The Secretary shall verify the eligibility of each voter, shall count and tabulate the votes, and submit them to an auditor designated by the Board of Directors. After auditing, if there are no discrepancies, the votes shall be returned to the Secretary for retention. If there is a discrepancy between the count of the Secretary and that of the auditor, the ballots shall be forwarded to the President for final decision. The Board of Directors shall direct the Secretary to send written notice of election results to all candidates and shall cause the results of the balloting to be published in the next regular issue of YL HARMONICS.

Sec. 3. On ballots involving the entire membership, a simple plurality vote shall govern in all matters except amendment of the Constitution and Bylaws, which shall require a 2/3 vote.

Sec. 4. On ballots of the Board of Directors, a majority vote shall govern in all matters except suspension of the Bylaws, which shall require a 2/3 vote.

#### ARTICLE X—ELECTIONS

Sec. 1. Prior to taking office on January 1st, the President shall appoint one of the newly elected District Chairmen to serve as Chairman of the Nominating Committee. The Chairman shall then appoint two more District Chairmen to assist her in selecting qualified candidates for each of the offices stipulated in ARTICLE III of the Constitution.

Sec. 2. In addition to the candidates selected by the Nominating Committee, any qualified member may be nominated for office by written petition of five members in good standing.

Sec. 3. No member may be nominated to office without her written consent.

Sec. 4. The Nominating Committee shall check on the eligibility of each candidate and shall cause to be published in the MAY/JUNE issue of YL HARMONICS, or in a special bulletin, a slate of candidates for office together with a brief review of each candidate's qualifications.

Sec. 5. Prior to July 1, ballots for the general election shall be provided to each member. Ballots may be included in the MAY/JUNE issue of YL HARMONICS if desired, provided each Family Member shall also receive a copy of the ballot.

Sec. 6. Voting shall be conducted in accordance with ARTICLE IX of the Bylaws.

#### ARTICLE XI—QUORUM

Sec. 1. The members participating in any meetings or voting shall be considered a quorum, providing all members have been notified of the activity by mail sent to the last address of record. Such notice shall be mailed at least six weeks prior to the closing date of the ballot.

#### ARTICLE XII—LEAGUE PAPER

Sec. 1. There shall be an official publication of the YLRL to be known as YL HARMONICS which shall be published by the Publications Committee in accordance with the provisions of ARTICLE VIII, Sec. 2. A copy of YL HARMONICS shall be supplied to every member of the League in good standing with the exception of Family Members.

Sec. 2. The expenses of YL HARMONICS shall be governed by the Board of Directors.

Sec. 3. Subscription to YL HARMONICS may be obtained by any interested persons upon payment of a subscription fee of \$3.00 per year, plus any foreign postage or air mail postage required. Subscriptions shall run from March 1st to March 1st.

#### ARTICLE XIII—AFFILIATED CLUBS

Sec. 1. Local clubs of women radio amateurs shall be eligible for YLRL affiliated Club Membership when 50% of the licensed members of such club are YLRL members in good standing. Written application for affiliation shall be made to the Secretary, accompanied by a roll of the membership of the club and designation of the geographical area covered. Election shall be by vote of the Executive Board. A Certificate of Affiliation shall be issued by the YLRL Secretary.

Sec. 2. Affiliation of the YLRL affiliated Clubs shall be renewable annually at the beginning of the club year and shall require submission of an up-to-date membership list and affirmation of eligibility.

Sec. 3. YLRL Affiliated Clubs shall be independent organizations and shall pursue no course of action in the name of YLRL without first obtaining written permission of the Board of Directors. If the name "YOUNG LADIES RADIO LEAGUE" or "YLRL" is incorporated in the name of the local club, it shall be qualified as to location or territory served by the local club.

Sec. 4. Any action or policy pursued by an affiliated Club which is in opposition to the



Constitution or policy or YLRL shall be cause for cancellation of affiliation within the discretion of the Board of Directors.

Sec. 5. For contest purposes, the membership of Affiliated Clubs shall be limited to those members actually residing within the geographical area specified in the application for affiliation.

#### ARTICLE XIV—AMENDMENTS

Sec. 1. An amendment to the Constitution or Bylaws may be proposed at any time by written request of five or more members. Such proposal shall be submitted to the Board of Directors who shall give it consideration, and, if approved, shall cause the proposed amendment together with appropriate ballot and explanation for the reasons for the proposal to be published in the next regular issue of YL HARMONICS, or a special bulletin. Voting shall be conducted in accordance with the provisions of ARTICLE IX of the Bylaws. Approved amendments shall be recorded by the Secretary.

Sec. 2. On questions of order and procedure not otherwise determined by these Bylaws, the provision of the current edition of Roberts' Rules of Order shall prevail.

Sec. 3. These Bylaws may be suspended in case of emergency by a 2/3 vote of the Board of Directors, provided subsequent notice is sent by mail to each member.

Sec. 4. The present Bylaws shall become effective January 1, 1959.

#### PROCEDURE POLICY

Sec. 1. The organizational divisions of the YLRL shall include one District from each of the United States amateur call sign areas; KH6; KL7; VE; and KZ5.

Sec. 2. It shall be the duty of the President to see that all monies, files and YLRL property are accounted for at the end of her term of office and she shall see that the duties of each officer are carefully carried out. She may appoint an assistant to any officer. She shall see that a minimum treasury of \$100.00 is always maintained.

Sec. 3. The Vice President shall be in charge of all League contests and shall purchase from League funds all prizes, awards and certificates as authorized by the Board. She shall receive and judge the logs for contests; submit a report of the results for publication. She shall be responsible for delivering the prizes and awards to the respective winners. With the aid of the District Chairmen, she shall keep informed of the normal operating hours and frequencies. She may appoint committees or assistants to aid her in specific branches of activities.

Sec. 4. The Secretary shall keep a permanent file of all applications for membership. All officers and Committee Chairmen shall keep the Secretary informed of the proceedings of any meeting, convention, special emergency nets, contest matters, etc. The Secretary shall keep a record of all YLRL Constitution, Bylaws and Procedure Policy Amend-

ments and the date of their adoption. Copies of the Constitution and Bylaws shall be made available to members. The Secretary shall maintain proof of votes of all elections or ballots for a period of 60 days after which time she may destroy same if there has been no question in the audit. It shall be the general policy of the retiring secretary to make sure each new officer has an adequate supply of information sheets and application cards.

Sec. 5A. The Receiving Treasurer shall prepare an up-to-date membership list at least twice a year, one being at the end of the Club year. These lists shall be made available to all officers, District Chairmen and Committee Chairmen. She shall issue membership cards upon receipt of dues. She will forward lists of new members to the Secretary so that she may send them a letter of welcome. The Receiving Treasurer shall also cause the publication of dues reminders in YL HARMONICS two months prior to the end of the fiscal year. She shall notify subscribers of the expiration of their subscriptions.

Sec. 5B. The Disbursing Treasurer shall pay all bills authorized in writing by the President or by the Board of Directors. However, the President may grant blanket authorization of payment of routine bills.

Sec. 6. The Editor, as Chairman of the Publications Committee, shall receive, edit and assemble all material for publication of YL HARMONICS. The Editor shall have the right to edit and condense any materials sent to her. She may call upon the President or the Board of Directors for decisions where there is doubt concerning the desirability of publishing certain material. The Editor shall have authority to appoint assistants for Special Features. An assistant may be appointed to provide special handling of HARMONICS. This assistant shall receive all surplus copies of HARMONICS and shall be responsible for mailing to new members not included in the regular mailing list. She shall investigate reports of HARMONICS not received and shall send replacements when warranted. Copies of HARMONICS which are returned because of change of address will be forwarded to this assistant. She shall have extra copies of HARMONICS available for sale and shall provide publicity copies to officers and Committee Chairmen upon authorization of the President.

Sec. 7. HARMONICS shall be mailed to each member in good standing except Family Members. A reasonable number of copies of HARMONICS will be supplied free of charge upon request of Officers and Chairmen for use in publicity and recruiting. Free copies of HARMONICS will be exchanged with other publications which may be of interest. Advertising space in HARMONICS shall be limited to no more than 50% of the total printing space. Acceptance of expenditures of publishing and mailing HARMONICS shall not be allowed to exceed 2/3 of the amount of the total annual dues.

Sec. 8. The Budget and Finance Committee shall audit the Disbursing Treasurer's books three months prior to the close of the fiscal year and again three months after the beginning of the fiscal year.

Sec. 9. It shall be the duty of all officers to keep proper records of all League equipment and supplies assigned to their custody and to keep records of expenses incident to the conduct of their office, regardless of whether or not they intend to donate such expenditures. These records shall be made available to the President, or Board of Directors upon request and shall be forwarded to the Disbursing Treasurer at the time of request for reimbursement or at the end of the Club year. The Disbursing Treasurer shall maintain these records in a permanent file and pertinent information shall be passed on to the succeeding officers. Retiring officers and chairmen shall pass to their successors all possible information that may be of assistance.

Sec. 10. On questions within the purview of the Board of Directors, the Secretary shall provide each member of the Board with a ballot and information concerning the question to be voted; this material to be provided by first class mail. Votes shall be in accordance with the provisions of ARTICLE IX of the Bylaws.

Sec. 11. The President shall appoint a Librarian who shall be prepared to furnish historical and current information about YLRL. She shall maintain a complete file of YL HAR-

MONICS from its inception. The Librarian shall attempt to compile a complete list of all licensed YLs in the world. The Librarian shall serve as an assistant to the Editor.

Sec. 12. The Membership Committee shall have Membership Correspondents for each of the following areas; Eastern Membership Correspondent; Western Membership Correspondent; and International Membership Correspondent. The membership Chairman may serve as Membership Correspondent for the appropriate area.

Sec. 13. In filling vacancies for unexpired terms, an officer who has served more than half a term shall be considered to have filled a full term of office. This provision applies to those officers appointed to fill unexpired terms as well as to elected officers.

Sec. 14. Should both the President and Vice President be unable to act, the Secretary shall notify the Board of Directors, who shall then designate an acting president.

Sec. 15. It shall be the general policy of the League to rotate officers so that no President or Vice President shall be from the same district as her predecessor.

Sec. 16. Adoption of International Members shall be made through the International Membership Correspondent. Dues for adopted

Sec. 17 The President shall appoint a Property Custodian or Supplies Chairman who will serve for an indefinite term. The Property Custodian will work closely with the Disbursing Treasurer since she will handle funds from the sale of pins, charms, etc. She will maintain other supplies for distribution to the officers in the conduct of their respective offices.

Sec. 18. "The President's Convention Travel Fund." This fund was established following the 1960 YLRL Convention to assist the YLRL President, at the time of a YLRL Convention, with travel expenses. This fund is completely separate from YLRL monies and is to be used for this purpose only. At the time this fund was established, it was hoped that each succeeding Convention Committee would find the means of rebuilding the fund, thus making it perpetual.

In the event the President is unable to attend, this fund could be used to assist the Vice President, or next major officer, designated by the President to represent her.

The disbursement of this fund is in the hands of the Disbursing Treasurer and the Finance Committee.

Sec. 19. There shall be a President's Advisory Committee composed of 6 Past Presidents of YLRL, each serving for two years. Each President shall appoint 3 Past Presidents to serve on this Committee with the three members appointed by the President preceding her.

The growth of YLRL has made it nearly impossible for any one person to have all of the background necessary in making major policy decisions. The purpose of this committee is to assist and advise the President, that she may be better equipped to carry out her duties.

Sec. 20. Definitions of votes shall be in accordance with Roberts' Rules of Order and the following interpretations shall apply:

**PLURALITY:** A candidate has a plurality vote when she has a larger vote than any other candidate.

**MAJORITY:** A majority vote means more than half the votes cast, ignoring blanks.

Sec. 21. The Procedure Policy may be amended by a 2/3 vote of the Board of Directors.

Sec. 22. In the event the Organization shall be dissolved, any monies remaining shall be distributed to the existing membership.
