Call to Order - Vicki Zumwalt, N6KLS

<u>President's Report</u> - Vicki, N6KLS introduced new appointees: Ann Finklesen, WA1S, Continuous Membership; thanks to Dawn Biocca, KB6LHP for serving; Kathleen Houlihan, WA5DUC, Marketing; Linda Robinson, W1MP, District 3 Chair; Linda Hynan, AC5QQ, Finance Chair.

<u>Vice President's Report</u> - Diane, K2DO, presented the report of the Scholarship Committee.
